**CAPMED OPDATERING 23 SEPTEMBER 2022**

Soos aangedui in Cryptique se omsendskrywes op die webblad van Capmed, is die handelsslisensie van ZARx opgeskort, as gevolg van nie nakoming soos deur FSCA van artikel 8(1) (a) van die Gedragsowerheid vir die Finansiële Sektor, vereis word.

ZARx het teen die besluit geappeleer en die aangeleentheid is egter nog hangende.

Die Direksie van Capmed en die bestuur, het besin oor die tydsverloop en dit oorweeg om self aansoek te doen om op die hoofbeurs te noteer.

Die JSE het intussen aanpassings gedoen wat dit makliker en goedkoper maak vir maatskappye, om op die hoofbeurs te noteer.

Capmed is tans besig met nuwe voorgestelde beursborge.

Derhalwe doen Capmed nou 'n aansoek om op ons eie voort te gaan met die lysing op die hoofbeurs.

Een van die vereistes is dat Capmed in die groep 'n entiteit moet hê met 'n winsgeskiedenis. Capmed loop al 'n lang pad met 'n maatskappy wat aan al die vereistes voldoen en hulle het reeds aangedui aan Capmed en die beursborge dat hulle met Capmed so 'n handelingsooreenkoms wil doen.

Om aan hierdie voorskrifte van die JSE te voldoen, is Capmed ook besig om met twee gevestigde netwerke van doktersgroepe, (In die RSA en internasionaal) soortgelyke handelsooreenkomste te sluit, wat in dieselfde tyd ook groot ledegroepe verteenwoordig.



## CIRCULAR

Dear shareholder

I acknowledge that I have not reported on the group's activities since May, but I was involved in some macro-negotiations.

Unfortunately all of these are covered by non-disclosure agreements (NDA's) only allowing information on a need to know basis.

Matters should become clearer towards the end of the year.

In the meantime:

1. With ZAR X's licence still suspended, this listing avenue remains closed, but more hard news is expected in October.
2. Cryptique explored a listing on the JSE, but with crypto-assets presently out of favour, no progress was made.
3. Cryptique has also been advised by associate Capmed Holdings that it is pursuing an own listing.
4. During a (sponsored) visit to the USA I had positive meetings with Afro-American investment groups that would assist in any New York listing.
5. Cryptique has substantially increased its range of fungible tokens (FT's) and non-fungible tokens (NFT's) that will form the backbone of the company's digital unit business. Most of the "white papers" have been written and Cryptique is negotiating with Megaton Devco on the implementation. The Saxon Diamonds transaction will greatly accelerate this.
6. By far the most important development since July is the proposed transaction between associate Equator Investment Holdings (previously Equator Mineral Holdings) to sell its interest in Saxon Diamonds (Pty) Ltd to a mining group.

The purchaser and most of the Saxon Diamonds shareholders (including Equator) have already signed the sales agreement (of 173 pages).

Equator's share in the purchase price will be substantial, but can only be finally quantified once certain suspensive conditions have been fulfilled.

7. It is expected that on receipt thereof Cryptique and Equator will be merged (which should not be difficult since they share the same directors) and a direct listing on the Nasdaq could follow.
